## **GENERAL BOOKING TERMS & CONDITIONS for Module C offered by Enerchi – Imperial Feng Shui School & Consultancy**

**1. PRIOR KNOWLEDGE:** Before signing this registration form, the student agrees that they have received all the relevant information about the Module C training programme; to include the objectives, Module C duration, course materials required, practical experience, your trainer, your organiser, examination and further education options, outline of Module C syllabus, teaching fees, payment options, banking information, session dates, timings, lunch, refreshments and venue.

**2. EFFECTIVENESS OF REGISTRATION:** Registration becomes effective when you complete your registration form, sign and date your contract agreement and email them to Master Pamela Forsyth (CH.DS.YHH), the school's organiser. The organiser will email the student confirmation of their place on the Module C course. The student's teaching fee payment for Module C is then due according to the payment option that the student prefers. The student will be sent an email with a receipt for their payment of the teaching fee.

**3. RIGHTS ON THE COURSE:** From the beginning of the course, students have access to the various services the school offers. The course is the Module C training programme, to become a Specialist in the Theory and Practice of Chue Style Feng Shui. This Module C course is taught by Master Teri Garcia (CH), who is licensed and certified to teach the Chue Style Training Programme by Grand Master Chan, president of the Chue Foundation. The student has the right to contact the Schools Advisory Board of the Chue Foundation at [www.chuefoundation.org](http://www.chuefoundation.org) if the student needs to submit evidence of any infringement of their rights on the course.

**4. CANCELLATION RIGHTS:** The student has 15 days to exercise their right of cancellation from the Module C course, which is from the date the student receives confirmation of their place on the course, after their registration. Cancellation needs to be made in writing to the organiser of Enerchi – Imperial Feng Shui School & Consultancy.

**5. PAYMENT OF COURSE:** The course costs £4608 for 24 days. Students can pay using the payment method that is most convenient for them. Enerchi – Imperial Feng Shui School & Consultancy offers several payment options:

**a) Full payment** of £4608 by the start of Module C Session. Or, 2 yearly payments of £2304 due by the start of Sessions 1 and 5.

**b) Session payments**, in advance of each session, by bank transfer of £576 per session. Alternatively, session payments are due on the first morning of each session, by cheque or cash for £576 per session. There are a total of 8 sessions in Module C.

**c) Monthly payment** by bank transfer of £230.40 x 20 months. The first instalment would need to be paid before the start of Module C.

**6. PAYMENT OBLIGATIONS:** After the 15 days of the student's right to cancel have lapsed, the student is obligated to choose either payment option a, b or c, with the intention of paying the total amount for the first four teaching sessions in 2017/2018. After these 4 teaching sessions, the student has the option to decide whether to continue the course in 2019. There is no obligation in 2018 to commit to or pay for the 12 teaching days in 2019, until the due date of payment for that part of Module C. If the student decides to continue the course in

2019, the student is then required to meet the full payment of those four sessions of three days, according to their chosen payment option. For all payments and any queries please contact Master Pamela Forsyth (CH.DS.YHH).

**7. NON-PAYMENT:** If the student does not meet their obligation to pay for the course that they have received, Master Pamela Forsyth (CH.DS.YHH), as the director of Enerchi – Imperial Feng Shui School & Consultancy is entitled to make a claim for payment of the total debt. If there are any bank charges and / or management fees in connection to reclaiming the debt, those costs will be added to the claim amount that the student is still due the school. Enerchi – Imperial Feng Shui School & Consultancy can choose to charge an additional 5% as interest on the debt amount, from the date of arrears until the date the full debt is paid by the student.

**8. NON ATTENDANCE:** It is the responsibility of the student to attend all the teaching sessions. If they are unable to attend a teaching session, the student must ask a course colleague to help them catch up with that session's information. The trainer is not obliged to teach that session to the student individually. The student needs to attend 80% of the sessions to receive the Certificate of Attendance and qualify for the exam. There will be no refund for missed teaching sessions.

**9. DATA PROTECTION:** Enerchi – Imperial Feng Shui School & Consultancy guarantees that the personal data of their students' will only be for direct use, with relevance to this course at this school. If the student needs to amend their data or wishes to have their data removed from the school's database, the student is required, by the law relating to the Protection of Personal Data, to write to the organiser of the school with this request.
